## **'Do what you like' at Burbage Carnival**

If the Government's roadmap to re-opening continues as planned, Burbage Carnival will be back on the streets on Sunday July 18.

The Parish Council is supporting the parade by paying for a County Council-approved schedule of rolling road closures, to allow the procession to proceed safely.

It is also to make a £500 donation to the volunteer Carnival Committee which organises the ever-popular community event.

Floats and other entries are being encouraged, with entrants invited to 'do what you like' rather than follow a set theme.

## Neighbourhood Plan is 'made'

Burbage Neighbourhood Plan, which went to referendum on Election Day in May, secured a positive majority vote of 85% and, as a result, has now been officially 'made'.

Councillors are delighted with the result and thanks have been expressed to all who have been involved in bringing the Plan to this point.

Policies contained within the Plan will be used to add weight to Council comments on future planning applications and were successfully cited in evidence and referred to by the Inspector at the Sketchley Fields public inquiry.



A swathe of Burbage countryside has been protected from development following a public inquiry at which Parish Councillors spoke out against proposals by Barwood Development Securities Ltd for 140 homes and up to 30,000 sq m of warehousing on land off Sketchley Lane, which had been refused by Hinckley & Bosworth Borough Council in May 2020.

In May this year, it was announced that the developer's appeal against the decision had also been dismissed,

following a nine-day public hearing held in March.

Parish Councillors Richard Flemming, who is chairman of the Neighbourhood Plan group, Cllr Mike Hall and Cllr Barry Walker all gave evidence to the Inquiry, highlighting the harm they feared the development would cause to Burbage and its residents.

Their opposition was mounted in a co-ordinated effort which also involved all five Burbage Borough Councillors.

## **New Chairman for Parish Council**


Liberal Democrat Councillor Keith Lynch has been elected Chairman of Burbage Parish Council.

The Member for Tilton ward was voted-in at the council's annual meeting on Monday May 24, which was the first in-person meeting of the full council to have been held since the first national lockdown came into force in March 2020.

Following a recent election and co-option, the council now comprises 16 Liberal Democrats, two Conservative and two independent members.

Outgoing chairman, Lash Hill ward councillor Richard Flemming said:

"I would like to thank all Council Members for their support and steadfastness throughout the pandemic, which has put untold pressure on us all to keep the business of the Parish Council running when we have not been able to meet face-to-face."


